## **2024 PROPERTY TAX PAYMENTS**

Tuesday, December 31<sup>st</sup> is the last day to pay property taxes at the town office before interest of 1.87% is applied on January 1<sup>st</sup> of the new year & each month thereafter, until the levy amount is paid in full.

If paying via EFT (online banking), ensure payments are made within 3 – 5 business days prior to December 31<sup>st</sup> in order for the payment to be reflected in the Town of Herbert's bank account to avoid an interest charge being applied on January 1<sup>st</sup>.

After April 30<sup>th</sup>, the 2025 tax year process begins & ratepayers can expect to receive Tax Notices in the mail by the end of May or beginning of June.
