General Elections are legislated by the Provincial Government to be held every four (4) years. The Herbert Municipal & School Board Election will both be held on November 13, 2024.

Elections are held in order to elect a Mayor & six (6) Councillors for the Town of Herbert. School Board Trustees are also elected for the Chinook School Division. Herbert is Subdivision 3.

The Provincial Government Election is Monday, October 28, 2024. For more information on the provincial election visit www.elections.sk.ca

Observe the following dates regarding the General / School Board elections for Herbert:

- Advance poll Wednesday, Nov. 6; 9 am – 4 pm Prairie Wind Estate – 1329 Herbert Avenue
- Local & School Board Election Wednesday, Nov.13; 8 am – 8 pm Lions Hall – 706 Railway Avenue

Voters will be asked to fill out a Voter's Declaration at the polling station.

### **VOTER ELIGIBILITY**

To vote in a city, town or village election in Saskatchewan, you must:

- be a Canadian citizen;
- be at least 18 years of age and one of the following;
- have lived in Saskatchewan for at least six consecutive months immediately before election day and:
  - a. lived in the municipality (or on land now in the municipality) for at least three consecutive months immediately before election day; or
  - b. be the owner of assessable land situated in the municipality (or land now situated in the municipality) for at least three consecutive months immediately before election day.

## ACCEPTABLE VOTER IDENTIFICATION

The purpose of the voter ID requirements is to maintain the integrity of local election processes. Your name and address must appear in some form on your voter identification documents. Bringing proper identification will ensure your voice

### RUNNING FOR MUNICIPAL OFFICE

It's not crucial to have education or experience in a government setting to run as a candidate. You likely have skills, knowledge and abilities that are transferable to the elected official's role.

You may want to undertake a self-assessment of your skills prior to running for elected office.

Think about your:

- Volunteer experience
- Community involvement
- Work experience
- Membership in different organizations
- Family life

Often your experiences have taught you how to:

- Work as part of a team
- Organize and prioritize
- Make decisions
- Debate
- Lead

### Photo ID – Your BEST option to take to the polls

Acceptable photo identification is ID that is **government**issued, valid and has your **photo**, **name** and **address**. If your identification does not meet these criteria, it will not be recognized as an acceptable form of photo identification.

Examples include:

- a valid Saskatchewan driver's licence;
- a valid Saskatchewan ID card issued by SGI or any motor licence issuer (available for \$10 or free for seniors); or
- any other valid government-issued photo ID issued by a Canadian government whether federal, provincial or municipal, or an agency of that government, so long as it includes your name and address.
