2025 PROPERTY TAX PAYMENTS

Wednesday, December 31st is the last day to pay property taxes at the town office before interest of 1.87% is applied on January 1st of the new year & each month thereafter, until the levy amount is paid in full.

If paying via EFT (online banking), ensure payments are made within 3 – 5 business days prior to December 31st in order for the payment to be reflected in the Town of Herbert's bank account to avoid an interest charge being applied on January 1st.

After April 30th, the 2026 tax year process begins & ratepayers can expect to receive Tax Notices in the mail by the end of May or beginning of June.

SNOW CLEARING & DISPOSAL SITES

The Town has designated disposal areas for large quantities of snow. Snow cannot be shoveled, bladed, blown or scooped onto any public sidewalk, street, boulevard, drainage ditch, culvert, or any property of the Town of Herbert.

If hiring someone for snow removal & the quantity of snow exceeds what the private property can accommodate, ensure the snow is sent to one of the following sites:

- 1) West side of the Sports Complex away from the building
- 2) At the Town's storage pits - North side of Connaught Ave.
- 3) West Lift Station (located west of Willoughby St. and Bison Ave.)
- 4) Town's aggregate storage area located North of Connaught Ave. & Brownlee St. - West side of the road/outside the gate
- 5) Storm field between Klassen St. and Lobethal St. - South of Bison Ave.
- 6) North end of Neidpath St. on empty lot in NE corner
- 7) West of The Cube - West of the alley by the trees
- 8) North of the former Catholic Church on Shaw St.
