

**TOWN OF HERBERT  
BYLAW NO. 2011-03**

**A BYLAW OF THE TOWN OF HERBERT  
TO PROVIDE FOR WEIGHT RESTRICTION OF VEHICLES  
WITHIN THE TOWN LIMITS**

**THE COUNCIL OF THE TOWN of Herbert, in the Province of Saskatchewan,  
enacts as follows:**

1. All of the provisions and enactments set forth in this Bylaw shall relate to and be in full force and effect within the limits of the Town of Herbert.
2. Shaw Street from the TransCanada Highway to Connaught Avenue shall be designated as a Heavy Vehicle Route. The Old Highway, also known as Railway Avenue South shall also be designated at a Heavy Vehicle Route.
3. Except as provided for under section 4, no vehicle on a street or lane within the limits of the Town of Herbert, including its load, shall exceed twelve thousand kilograms (12,000 kg).
4. Notwithstanding section 3, a vehicle, including its load, may exceed the limitations established in section 3 if:
  - (a) The vehicle makes local deliveries or pickups while being operated to or from the point of delivery or pickup by the shortest route from the Heavy Vehicle Route: or
  - (b) The vehicle is owned or contracted by the Town of Herbert while actually in the service of the Town of Herbert.
5. No vehicle over 12,000 kg as provided for under section 4, shall be stopped for longer than 30 minutes while making deliveries or pickups.

6. Any contractor or company who requires a vehicle in excess of 12,000 kg to complete their work, hired by a private citizen or business to do work within the limits of the Town of Herbert, must obtain a permit from the Town Office shown on Schedule 2, attached to and forming part of this Bylaw.
7. Any person found guilty of an infraction of this Bylaw or any part thereof, shall be liable on summary conviction, to the penalties prescribed by the General Penalty Bylaw of the Town of Herbert (Bylaw 2006-15).
