

**TOWN OF HERBERT
BYLAW NO. 2012-02**

**A BYLAW OF THE TOWN OF HERBERT
TO RESTRICT WATER USAGE OF THE
TOWN OF HERBERT WATER SUPPLY**

WHEREAS, the Council of the Town of Herbert deems it necessary to warrant restrictions of water usage by consumers in the Town of Herbert, due to demand exceeding supply;

NOW THEREFORE, the Council of the Town of Herbert, in the Province of Saskatchewan, enacts as follows:

1. STAGE 1 – ALTERNATE DAYS WATERING

The following schedule is to be observed when watering lawns and gardens:

- a) Even numbered houses will water on even numbered calendar days, between the hours of 7:00 a.m. to 10:00 a.m., and 7:00 p.m. to 10:00 p.m. only
- b) Odd numbered houses will water on odd numbered calendar days, between the hours of 7:00 a.m. to 10:00 a.m. and 7:00 p.m. to 10:00 p.m. only.
- c) Properties equipped with an automated time clock sprinkler system may only water between the hours of 11:00 p.m. to 5:00 a.m. on the days permitted by the watering regulations as described above.

2. STAGE 2 – TWICE A WEEK WATERING

If the Administrator gives notice that, in accordance with a Council resolution, a reduction in water use is necessary requiring Stage 2 restrictions, the following shall apply:

- d) Even numbered houses will water on Saturdays and Tuesdays, between the hours of 7:00 a.m. to 10:00 a.m., and 7:00 p.m. to 10:00 p.m. only
- e) Odd numbered houses will water on Sundays and Wednesdays, between the hours of 7:00 a.m. to 10:00 a.m. and 7:00 p.m. to 10:00 p.m. only.
- f) Properties equipped with an automated time clock sprinkler system may only water between the hours of 11:00 p.m. to 5:00 a.m. on the days permitted by the watering regulations as described above.

3. STAGE 3 – ONCE A WEEK WATERING

If the Administrator gives notice that, in accordance with a Council resolution, a reduction in water use is necessary requiring Stage 3 restrictions, the following shall apply:

- g) Even numbered houses will water on Saturdays between the hours of 7:00 a.m. to 10:00 a.m., and 7:00 p.m. to 10:00 p.m. only
- h) Odd numbered houses will water on Sundays, between the hours of 7:00 a.m. to 10:00 a.m. and 7:00 p.m. to 10:00 p.m. only.

- i) Properties equipped with an automated time clock sprinkler system may only water between the hours of 11:00 p.m. to 5:00 a.m. on the days permitted by the watering regulations as described above.
- 4. Exemptions for the above watering restrictions may be granted for newly seeded or sodded lawns upon notification to the Town Office. Such exemptions shall be limited to six weeks in length.

PENALTIES

- 5. Any person who contravenes any of the watering schedule restrictions shall be liable to the following penalties:
 - a) First Offence – warning by registered mail or personal service of the violation,
 - b) Second Offence – One hundred dollar (\$100.00) fine,
 - c) Third Offence and Subsequent Offences – Three hundred dollar (\$300.00) fine and watering privileges restricted further upon Council discretion.
