ACCEPTED

- Branches
- Grass clippings
- Leaves & garden refuse
- Unpainted & Unstained wood
- Metal & Whites (Large Appliances)*

*White fee - \$10 per LARGE appliance payable at the Town office; or ratepayer will be invoiced accordingly.



At any given time, wet & muddy road conditions will see the Transfer Station CLOSED to the public until the roadway, & dump site, are dry enough for accessibility.

A 30-yard roll-off bin provides an alternate disposal source for waste items too large for waste carts with the following exceptions. Please observe the NOT ACCEPTED items.

BIN FEES:

\$25.00 minimum

\$50.00 per full 1/2-ton load

**Cash not accepted at station.*

Applicable fees are at the sole discretion of attendant, & notated for invoicing.

NOT ACCEPTED in bin

- Household garbage
- Tires/Oil/Oil Filters
- Excessive amounts of any type of construction/demo materials like Gyproc, shingles, etc.

Hazardous Household Waste:

Adhesives, automotive, batteries, cleaners, corrosives, fuels, mercury, oxidizers, poisons, pharmaceuticals, propane cylinders, ammunition or solvents, etc.

Concrete & pavement not accepted due to lack of space.

Residential Single Stream Curbside Recycling

What Is Single Stream

Single-stream recycling is a system in which all recycle materials – fiber, plastics, tin, and aluminum – are placed, unsorted, in the Recycle Cart or Container. With our weekly or bi-weekly single-stream cart residential collection program, Triways Disposal can help divert approximately 40% of your household waste from your local landfill! An easy and convenient way to divert waste from the garbage stream and all your recycling being picked up at one location — your home!

All approved recyclables can now be placed together in the recycle cart. Accepted materials are listed below. Other materials for recycling will be added in the future as the necessary processing equipment is put into place. The recycle cart will be picked up in a timeframe that will allow the capacity of the cart to be utilized most efficiently.

ALLOWABLE MATERIALS

Paper & Cardboard

- Flattened corrugated cardboard and paperboard (empty cereal boxes, empty detergent boxes, empty tissue boxes)
- Newspaper, flyers, inserts, junk mail, and envelopes
- Magazines, catalogues, telephone books, paperback books, hardcover books with covers and spines removed
- Brown paper bags, tissue roll cores, gift and packing paper, paper egg cartons
- Copier paper, NCR (no carbon required) paper

Aluminum & Tin

- Soft drink and beer cans
- Foil trays and pie plates
- Household tin cans (please rinse)

Plastic

- Containers with logo 1-7-No Food containers (Clam Shells) labelled #1
- Plastic drink bottles
- Aseptic Packaging & Cartons
- Juice and milk cartons, milk jugs, tetra-pak containers, pouches



NON-ALLOWABLE MATERIALS

- Household garbage, organics, or hazardous waste
- No food containers (clam shells) labelled #1
- No plastic bags or plastic wrap
- Glass
- Waxed, plasticized or food-contaminated paper, cardboard cups or plastic plates
- Soiled tissues, napkins, and paper towels
- Yard waste/grass clippings with your organics
- Confetti shredded paper
- Styrofoam or other foam packing materials
- Auto parts or batteries
- No oil containers or chemical jugs
- Wood
- Metal
